Kayak Pool Corporation ("Kayak™") warrants to the to the original consumer purchaser ("Purchaser") of this Kayak™ Composite Waterwall™ ("Wall") the following protection subject to the terms and conditions hereinafter mentioned:

For so long as the Purchaser shall own the Wall, Kayak<sup>TM</sup> will warrant the Wall to be free from defects in material and workmanship. Kayak<sup>TM</sup> will repair or provide a replacement, at its option, for any such Wall which fails as a result of a manufacturer's defect in accordance with the following schedule and procedures. Proof of date and place of purchase is required to validate this warranty.

The following schedule sets forth the percentage of the retail price, in effect at the time, which the Purchaser will be charged for repair or replacement. The percentages are based on the length of time you have owned the Wall from the date of purchase.

Within the 1st to 3rd year
Within the 4th year
Within the 5th year
Within the 6th year
Within the 7th to 10th year
From the 11th year on

0% of current retail price 30% of current retail price 40% of current retail price 55% of current retail price 70% of current retail price 80% of current retail price The retail price shall be Kayak's suggested retail rice in effect at the time of replacement. Repaired or replaced components will be returned to the Purchaser freight prepaid during the first three years; but at the purchaser's expense thereafter. You must install or pay for installation of the repaired or replacement part.

This warranty shall be void unless the Wall has been installed and maintained according to Kayak™ instructions.

## This warranty shall be void if you backfill or bury the Wall.

Our obligation to repair or replace is subject to our inspection and agreement that the cause of damage is due to a manufacturing defect. The Wall must be returned to the factory, clean and dry with the defect clearly marked and packaged so as not to permit damage in transit, and shipped freight prepaid.

All product claims under this Warranty must be returned at the Purchaser's expense to Kaya $k^{TM}$  at the address set forth below.
